APPROVAL OF FEBRUARY 21, 2023 REGULAR MEETING MINUTES

UPDATE/STATUS: MONTHLY FINANCIAL AND OPEN CAPITAL PROJECTS REPORT

DISCUSS/APPROVE METER AND CAPACITY FEES

Staff presented a recommendation to allow plumbers to make residential taps and a modified meter and capacity fee was recommended in response to the plumber providing some of the materials the District typically included. The 5/8" meter fee went from \$1,000 to \$750 and the 1" meter fee went from \$1,550 to \$875. Also, the System Improvement Fee was changed to a Capacity Fee to better reflect the purpose of the charges.

Barry Frost made a motion to accept staff's recommendation, which was seconded by Brian Leonard, to approve the modifications to the meter fees and verbiage of fees effective April 14, 2023.

- Billy Cothran informed commission regarding the results of the SJWD Employee Culture Survey. A follow up survey was emailed to employees March 21st.
- Eddie Tallon informed the commission that Water Professionals Day was observed on March 6, 2023. Eddie stated the LCI committee will codify the bill to establish Water Professionals Day be observed the first Monday of March every year.
