BID SUBMITTAL: Bids must be in a sealed envelope marked "Surplus Vehicles Sealed Bid No. 2020-1". The name, address, and telephone number of the bidder must also be listed on the outside of the envelope. Bids must be submitted on the provided form only, signed by an authorized signatory of the bidder, and be delivered by mail or in person. Bids emailed or otherwise electronically submitted cannot be accepted and will be rejected.

BID OPENING: Sealed bids will be accepted until 2:00p.m. EST on August 31, 2020 at the SJWD Main Office (307 Spartanburg Hwy., Wellford, SC 29385) at which time they will be publicly opened and read aloud. Bidders are not required to be present at the bid opening.

BID AWARD: The bid will be awarded to the highest responsive and responsible bidder. Bid award will be posted on the SJWD's website at www.sjwd.com. SJWD reserves the right to reject any or all bids in total or in part and to waive any informalities and irregularities, as it may deem to be in SJWD's best interest. In the event of a tie between the highest bids, the bid award will be determined by the date the bid is received (i.e. award to earlier bid received date). If there is still a tie, a resubmission between the highest bidders will be necessary.

PAYMENT AND REMOVAL OF PROPERTY: Payment must be in the form of a cashier's check or certified check made payable to the SJWD Water District. Full payment must be received, and the property removed from SJWD premises at the buyer's expense not later than 5 business days after award. Refunds or exchanges are not allowed and will not be considered.
